PRODUCT DEVELOPMENT

HENCO SOLUTIONS has a strategic partnership with an R&D company that develops our products according to our specific requirements and those of our clients. The R&D unit is staffed with researchers, chemists and engineers from a wide range of backgrounds in various industries.

SELECTION OF INGREDIENTS

HENCO SOLUTIONS' products - current and planned - will be made without the use of solvents, bleaches, nitrates, ethers, ammonia or other dangerous substances that are damaging to the environment or harmful to the users, so:

Many of our chemical components are classified as Food Grade without compromising the end product's performance

We avoid using fragrances and dyes since these components often harm the environment and may cause allergic reactions

We reduce chemical use by (i) increasing the efficiency and concentration of each HENCO SOLUTIONS formulation; and (II) excluding thickening agents
